WHEREAS, the Mon Valley/Fayette PA Route 51 to 1-376 Project, also known as the Mon/Fayette Expressway (MFE), is the final of four Mon/Fayette projects that would provide a four lane, limited access expressway from I-68 in West Virginia to I-376 in the Pittsburgh area; and

WHEREAS, The PA Route 51 to I-376 Project obtained a Record of Decision from the Federal Highway Administration in December 2004 Identifying the Selected Alternative to be designed and constructed; and

WHEREAS, the alternative moved into the Final Design process but was put on hold in 2009 due to lack of sufficient funding for construction; and

WHEREAS, with the passage of Act 89 of 2013 which provides the Pennsylvania Turnpike Commission (PTC) a 14 percent share of revenue collected from a 55-mil oil company franchise tax levy; and

WHEREAS, this money is to be used for projects specified in the Tumpike Organization, Conversion and Extension Act of 1985; and

WHEREAS, the PTC in 2015 deduced the MFE extension qualified as an Act 89 recipient and put it on the list of projects to receive those funds; and

WHEREAS, funding is once again available to move this project forward; and

WHEREAS, on March 20, 2017 the Southwest Pennsylvania Commission (SPC) voted to table the project; and

WHEREAS, the Pennsylvania Turnpike Commission announced "that it will stop engineering-design activities on the 14 mile MFE project in Allegheny County in light of the SPC recent decision to table the project" citing that "this is a regional project, and the decision as to whether it is of value to the region should be made by those who live there." And

WHEREAS, an August 2016 report on the MFE by the national transportation organization TRIP cited the creation of 20,780 permanent jobs as well as more than 5,000 annual construction jobs; and

WHEREAS, supporting documentation for the above figures may be lacking, however it is believed that the MFE will alleviate the congestion along Rt. 51 corridor as well as create construction and engineering jobs in the region; and

NOW, THEREFORE, the Council of the Borough of Baldwin, Allegheny County, Pennsylvania, hereby calls upon its State Elected Officials to support the Mon/Fayette project and urges the SPC to reconsider their action on the project.

Re: Mon-Fayette Expressway status and Route 51 to Interstate 376

As stakeholders and public leaders, all of us share a common interest in sustaining and growing our region, with the City of Pittsburgh as epicenter. It is in this spirit of cooperation that we ask the SPC to reconsider its decision to "table" pursuit of the final 14 miles of the Mon-Fayette Expressway from Route 51 to Interstate 376 by excluding this long-term project from the 2017-20 Transportation Improvement Plan.

The consequences of the March 20 action has already resulted in deleterious fallout inasmuch as the Pennsylvania Turnpike Commission has stopped design, engineering and related activities, saying it will not serve in an advocacy role. Ergo, the SPC and PTC are further delaying a major transportation improvement that would have been open to its original destination and serving valuable purpose if it were not for a variety of objections raised in the past and often found to be of questionable merit.

Construction that has been accomplished in segments, starting in 1973, is well documented. But "missing links" have thwarted fulfilling potential. Too much time has been wasted. We need to think and act as a region before we lose another generation of dreams, opportunities and young people.

For years, public officials have bemoaned the lack of an "outer beltway" for the Pittsburgh metropolitan area. What already exists, combined with completing the Mon-Fayette Expressway and Southern Beltway, would fulfill that need. It also would enhance "spurs" such as I-279 and

Route 28, relieve traffic pressure on I-376 and expand options for personal travel and commerce throughout the 10-county region.

References to a \$1.6 billion cost and 2035 completion date mislead many people into believing the futility of an infrastructure investment that, in reality, has been a work in progress since the Turnpike began building the Beaver Valley Expressway, Greensburg Bypass, Mon-Fayette Expressway and Southern Beltway. We invite you to visit the latter corridor and see for yourselves the enormous benefits that the initial 6-mile segment has spawned, including building a GE research facility and state-of-art Gordon Foods distribution center relocated here from Columbus, Ohio. Development related to the MFX has been slower but significant, minimizing troubling population and job losses.

Notably, oil franchise taxes and motor vehicle registration fees earmarked for toll roads expansion by the State Legislature that had been generating revenues in the \$60 million-a-year range a decade ago are estimated to increase to more than \$140 million a year as a result of Act 89 of 2013, thereby financing continuing progress on the MFX and Southern Beltway.

In latter stages of highway planning, each segment was designed to be independently functional and justifiable. For example, the segment from the existing "dead-end" of the MFX in Large would extend limited-access travel north to Lebanon Church Road. It could be built and open within six years, serving the Allegheny County Airport, US Steel Corp.'s Irvin Works, Bettis Atomic Power Lab and others. The next segment would connect to Route 837 in Duquesne, serving Kennywood, US Steel Corp.'s Clairton Works, Duquesne Industrial Park and, by extension, enable time-savings travel to Sandcastle, the Waterfront complex in Homestead, the Rankin Bridge to the Parkway East and Glenwood Bridge.

That's looking to the future. That's helping existing business. That's saving jobs. That's attracting business. That's regional vision and investment.

The magazine, "Pittsburgh Quarterly," which benchmarks us with other comparable metro areas, pointed out in its most recent issue that annual traffic delays here have risen 15 percent since 2003. The automobile will remain the preferred mode of travel for the foreseeable future.

However, as society evolves into driverless vehicles, new mobility strategies, energy-saving technology, light-rail extensions or innovations not yet imagined, expressway rights-of-way procured today will be invaluable assets for the future.

We recognize there will always be pros, cons, questions and alternatives to new capacity highways. Many apply when it comes to the "cap" over I-579, Bus Rapid Transit between Downtown and Oakland, a \$100 million upgrade of the Banksville Interchange at the Fort Pitt Tunnel and other arguably discretionary projects. We have heretofore supported those and other investments, often at the expense of transportation and development initiatives to benefit our own counties.

In context, the Pennsylvania Turnpike Commission already maintains and operates 100 miles of the east-west mainline through the 10-county region encompassed by the SPC. An equal number of miles of expansion projects, including 60 continuous miles of the Mon-Fayette Expressway, represent "trunk

lines" that carry a substantial volume of commercial, interstate, regional and local traffic. Imagine Southwestern Pennsylvania without them!

We need to be visionary and optimistic, not parochial and pessimistic. Completion of the Mon-Fayette Expressway and Southern Beltway can help reverse population and jobs losses, provide new corridors for spin-off development from the new Shell Chemical "cracker plant" and help fulfill the mission and expectations of the SPC as a "regional" organization as its name once designated.

We implore fellow SPC members to re-think their decision, to imagine lost potential if we leave these as "roads to nowhere," and to solidify the symbiotic relationship established over the years for the mutual benefit of everyone whom we represent as a body.

Dear Friend:

I am writing to urge you to consider adopting a resolution at your municipality's next regular meeting in support of the completion of the Mon-Fayette Expressway Project. I also respectfully request that you and your colleagues submit letters of support to the Southwestern Pennsylvania Commission (SPC), Allegheny County Executive and secretary-treasurer of the SPC, Rich Fitzgerald and the Pennsylvania Tumpike Commission (PTC).

As a lifelong resident and elected official representing the majority of the Mon Valley's economically distressed communities, I wholeheartedly disagree with the SPC's decision to table pursuit of the final 14 miles of the Mon-Fayette Expressway from Route 51 to Interstate 376 by excluding this long-term project from the 2017-2020 Transportation Improvement Plan (TIP). Rather than placing bureaucratic roadblocks in the Pennsylvania Turnpike Commission's way, we should applaud their perseverance and leadership in making such a crucial investment in the Mon Valley. Additionally, the state Legislature earmarked funding for the extension and those funds cannot be allocated to any non-turnpike extension projects.

The Mon-Fayette Expressway is the foundation of the Mon Valley's future. The extension of the Expressway would open the Mon Valley to businesses from West Elizabeth through West Homestead along the Monongahela River. With over 1,000 acres of developable property for business and industry, the Expressway would also align itself with river and rail traffic, creating job opportunities. With points in West Mifflin and Dravosburg, the Expressway has the potential to increase air traffic and cargo for the Allegheny County Airport. The continuation of the Mon-Fayette Expressway from Jefferson Hills to the Parkway East would create a transportation link for businesses in the Mon Valley and Turtle Creek region, providing these companies with improved production capabilities, as well as national recognition. A report on the Expressway project issued last August by the national transportation research group, TRIP, cited the creation of 20,780 permanent jobs, as well as more than 5,000 annual construction jobs. These jobs would deter crime and create growth in the Mon Valley's depressed communities.

The extension of the Martin Luther King Jr. East Busway from Swissvale to a proposed Expressway interchange in East Pittsburgh would also help reverse population and job losses. The

value of the busway extension and the Expressway was cited not only in the TRIP report but also in the transportation Action Plan (TAP) published last fall by the Construction Legislative Council (CLC) of Western Pennsylvania. Both reports noted how the Expressway combined with the East Busway would vastly improve regional transit access and reduced traffic congestion on the Parkway East by providing direct transit access into the City of Pittsburgh.

There are many opportunities that will be created through the completion of the Mon-Fayette Expressway. Although we may not see such opportunities develop in our lifetime, the Expressway will offer hope and a reason for future generations to remain in the Mon Valley.

The first step towards this effort will require the SPC to change course and authorize the Expressway to proceed. Then, as a region, we should work together with the Pennsylvania Turnpike Commission to ensure that the Expressway is constructed in a timely manner. It is in this spirit of cooperation that I ask you to submit resolutions and letters of support for the Mon-Fayette Expressway Project.
